Second student replied "Nobody want to know about your bloody ass!" then wall walked over to her with a pencil in her hand and said "You lucky, don't test me!" and "You testing me?" apparently the pencil was within a few inches of her left eye and she felt threatened, some classmates intervened to hold the 2nd student. DMC Faculty was informed of the incident and went to talk to DMC department Chair. Officers questioned 2nd female student and she admitted walking up and pointing her finger on the other student's face, she did not mention the pencil when she pointed the finger. After determining there was no threat CCPD officers departed the premises. Security officer stayed to take a statement 2nd female student apologize but the offended student refused to accept the apology. 2nd female student began questioning herself, sobbing and made a comment about jumping off a bridge. After the 2nd female regained her composure and was not threat to herself or anyone else she resumed her daily routine and all officers cleared the scene.
