The subject left his black backpack by the computer station. I was given the internet history by the DMC Staff of the subject's searches. DMC Staff said he recorded a video of the male viewing pornography. He made a copy of the video on a flash drive and gave it to me. CCPD Officer (Unit 1) arrived on the 5th floor to standby while I conducted a walkthrough of the building. I made contact with the male subject, (Non DMC) walking out of the elevator on the 5th floor. I asked him to walk with me to room 528 to make contact with CCPD Officer. Officer informed the male that he was witnessed looking at unauthorized websites. Stated that it was pop ups and he closed them down quickly. Officer asked for a driver's license or any other identification. I had him confirm his User ID shown on the print out history. The male verified the User ID. CCPD Officer informed me that the driver's license came back clear. I informed The male suspect that I was issuing him a Criminal Trespass Warning and he would not allowed back on Del Mar College property. If he was found on Del Mar property, he would be arrested. Officer confirmed my statement. The Male suspect read over the Criminal Trespass Warning and signed it. He asked if he could object to the CTW, he was told to call the phone number located on the Criminal Trespass Warning form if he needed to speak to someone. He said he would talk to the Dean tomorrow to have the Criminal Trespass Warning removed. Officer and I escorted him from the White Library and watched him leave the property without Any further incident.

She wanted to report a male subject who threatened her this morning at 9:30 am in the Richardson Performance Hall parking lot. Student stated she had just arrived when the male subject approached her. She described him as a Hispanic man in his 30's, bald, dark completed, 5'6, mustache, wearing a long gray shirt and gray shorts. The male subject had been across the street with a grocery cart that contained a vacuum cleaner. He left the cart and came running across the street toward her yelling at her. He told her he was going to kill her. He also told her she was the reason his son was in a coma. Before he ran back across the Ayers Street, he told her she was going to die. Student says she did not know the man. He left in an unknown direction. Unit 1 CCPD Officer Security Manager, Security Officers searched the area but could not locate the male.
